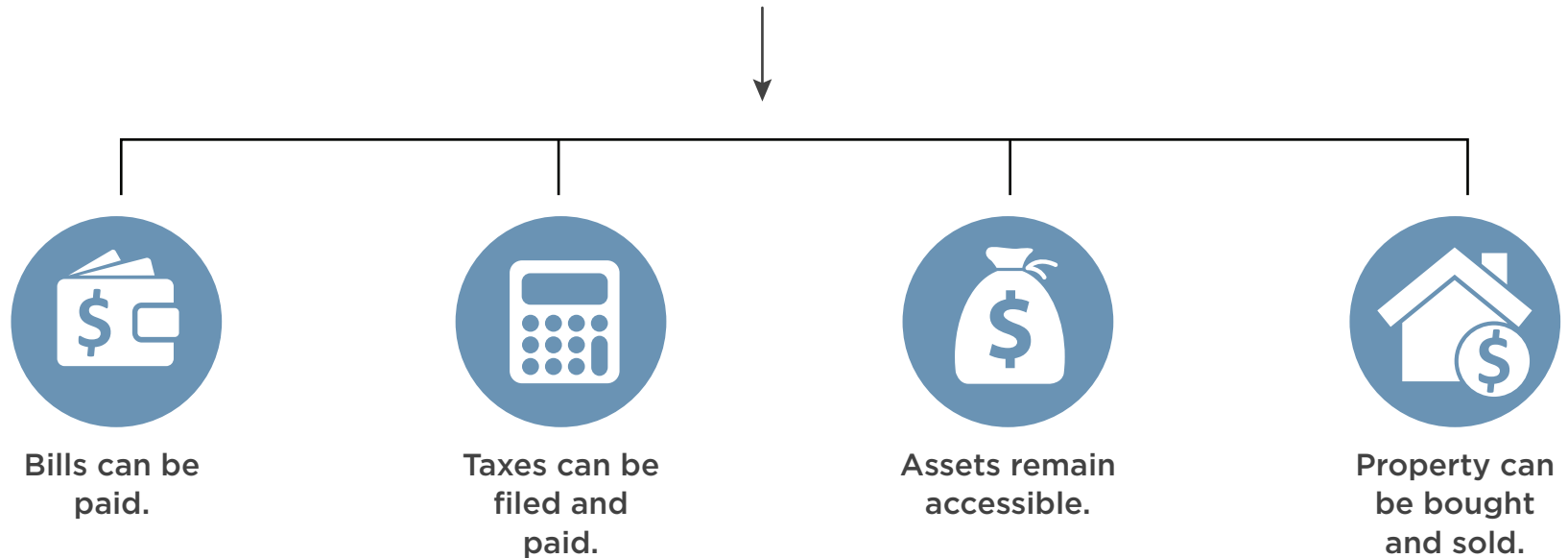

How much authority should they be given?



When should the FPA take effect?

YOU ALREADY HAVE JOINT OWNERSHIP—WHY ISN'T THAT ENOUGH?

Don't rely on joint ownership for asset management during incapacity!

This strategy is unreliable and comes with several risks, including:
