Personalized Care Planning Packages

All Care Planning packages include personalized and detailed wishes for: care during your lifetime, funeral arrangements, medical decisions, financial decisions, and instructions to agents.

EMERGENCY MEDICAID QUALIFICATION Care Planning Package\$9,500

- Preparation of required documents to protect assets and receive Medicaid eligibility
- Full Financial Analysis,
- Full report with review of assets reported to government for 60 month look-back period
- Medicaid Asset Protection Letter
- Medicaid Asset Protection Trust

LAST WILL AND TESTAMENT Care Planning Package \$1,500

- Will with outright distributions, testamentary trusts for minor or disabled beneficiaries [Important: testamentary trust NOT RECOMMENDED if/when minor has child, is emancipated and under the age of 18]
- Financial Power of Attorney with additional powers
- Psychiatric Advanced Directives

REVOCABLE LIVING TRUST Care Planning Package \$2,500 single

- Revocable Living Trust with disability provisions for control and outright distributions at death, standby trusts for minor or disabled beneficiaries
- Pour-over will
- Financial Power of Attorney with additional powers
- Psychiatric Advanced Directives
- Health Care Advanced Directives, including Healthcare Power of Attorney with living will powers

OPTIONAL ADDITIONAL TRUSTS

The following trusts may be added to the Last Will and Testament Care Planning Package and Revocable Living Trust Care Planning Package listed above.

ASSET PROTECTION Trust \$1,000

This type of trust provides lifetime asset protection for yourself, your spouse and/or your children. It may also provide protection of your assets if your spouse remarries after your death.

MINOR or SPECIAL NEEDS Trust \$1,000

This type of trust provides asset protection for minor or disabled beneficiaries.
