DEFAULT JUDGMENT AND ORDER OF DISTRIBUTION

The Plaintiff State of Georgia having moved for a default judgment against any and all interest Martinez Arnold may have in Defendant Personal Property, and the Court having read and considered the motion, IT IS HEREBY ORDERED that the motion is GRANTED.

More specifically, the Complaint for Forfeiture naming Martinez Arnold as an alleged owner / interest holder of certain items of personal property was filed on July 7, 2022 pursuant to O.C.G.A. § 9-16-12. The following items of Defendant Personal Property were seized from Martinez Arnold or from inside a vehicle registered to him and named in the Complaint for Forfeiture and to which no other alleged order/interest holder has made a claim¹:

- 5. Item 73 on Addendum A: Diamond tennis necklace with diamond "DUKE" pendant, Complaint ¶ 44;
- 6. Item 74 on Addendum A: Diamond "SHADY BABY" ring, Complaint ¶ 44;
- 7. Item 75 on Addendum A: Diamond cuff bracelet, Complaint ¶ 44;
- 8. Item 82 on Addendum A: Two (2) diamond stud earrings in rose gold setting, Complaint ¶ 45;

Martinez Arnold was personally served by a deputy with the Fulton County Sheriff's Office pursuant to O.C.G.A. §§ 9-16-12(b) and 9-11-4(c)(1) on July 19, 2022. A copy of the Sheriff's Entry of Service was not filed until August 1, 2022, which started the 30-day clock for Martinez Arnold to file an Answer to the Complaint for Forfeiture pursuant to O.C.G.A. § 9-16-12(c)(1). Martinez Arnold did not file an Answer by the 30-day deadline, August 31, 2022 and was thus in

default. Pretermitting whether the 15-day statutory extension of the 30-day deadline found in O.C.G.A. § 9-11-55(a) even applies to civil forfeiture actions, Martinez Arnold did not file an Answer within 45 days of the filing of the Sheriff's Entry of Service. Nor has Martinez Arnold filed an Answer *or any motion or other pleading whatsoever* in this civil forfeiture proceeding as of the date of this Order. Martinez Arnold's default acts as an admission of "each and every material allegation" in the Complaint. *Hansford v. Veal*, 369 Ga. App. 641, 644 (1) (2023). Additionally, Martinez Arnold is estopped from denying the essential allegations of Fulton County Superior Court case number 22SC183572 wherein he pleaded guilty to one count of Conspiracy to Violate the Racketeer Influenced and Corrupt Organizations Act and one count of Unlawful Participation in Criminal Street Gang Activity.

Accordingly, it is hereby **ORDERED** that any and all right, title, and interest that Martinez Arnold may have in the following Defendant Personal Property is **HEREBY FORFEITED TO THE STATE OF GEORGIA**:

- 4. Item 72 on Addendum A: Diamond Cuban link chain necklace with trapezoidal clasp, Complaint ¶ 44;
- 5. Item 73 on Addendum A: Diamond tennis necklace with diamond "DUKE" pendant, Complaint ¶ 44;
- 6. Item 74 on Addendum A: Diamond "SHADY BABY" ring, Complaint ¶ 44;
- 7. Item 75 on Addendum A: Diamond cuff bracelet, Complaint ¶ 44;
- 8. Item 82 on Addendum A: Two (2) diamond stud earrings in rose gold setting, Complaint ¶ 45;

The State shall immediately take and/or retain possession free and clear of all liens and encumbrances of the below-listed items of property seized from Martinez Arnold and that have not been claimed by any other party, and the below-listed items property shall be considered "proceeds," as that term is used in O.C.G.A. § 9-16-2(9).²

- 5. Item 73 on Addendum A: Diamond tennis necklace with diamond "DUKE" pendant, Complaint ¶ 44;
- 6. Item 74 on Addendum A: Diamond "SHADY BABY" ring, Complaint ¶ 44;
- 7. Item 75 on Addendum A: Diamond cuff bracelet, Complaint ¶ 44;

These proceeds shall be considered forfeited to the State of Georgia and distributed in accordance with O.C.G.A. § 9-16-19 as follows:

1. In accordance with O.C.G.A. § 9-16-19(c)(1), the Fulton County District Attorney's Office, as the seizing law enforcement agency and prosecuting office, shall sell by any commercially feasible means the seized and forfeited WHITE 2021 MERCEDES-BENZ AMG GT (VIN# W1K7X8JB8MA036940) and the seized and forfeited jewelry proceeds, with the proceeds from the sale, minus any costs incurred in the sale, to be

distributed to the Fulton County District Attorney's Office, and which amount shall be used for official law enforcement and prosecutorial purposes pursuant to O.C.G.A. § 9-16-19(f).

2. The Fulton County District Attorney's Office, as the seizing law enforcement agency and prosecuting office, shall retain the seized and forfeited FOUR THOUSAND ONE HUNDRED TWENTY-SIX AND 00/100 DOLLARS (\$4,126.00) IN U.S. CURRENCY to be used for official law enforcement and prosecutorial purposes pursuant to O.C.G.A. § 9-16-19(f).
