**PRELIMINARY INJUNCTION ORDER**

Plaintiff Yiwu Baimei Electronic Commerce Co., Ltd. (“BAIMEI”) filed a Motion for Entry of a Preliminary Injunction against the fully interactive, e-commerce stores<sup>1</sup> operating under the seller aliases identified in Schedule A to the Complaint and attached hereto (collectively, “Defendants”) and using at least the domain names identified in Schedule A (the “Defendant Domain Names”) and the online marketplace accounts identified in Schedule A (the “Online Marketplaces”). After reviewing the Motion and the accompanying record, this Court GRANTS BAIMEI’s Motion in part as follows.

This Court finds BAIMEI has provided notice to Defendants in accordance with the Temporary Restraining Order entered September 2, 2025, [DOCKET NO. 18] (“TRO”), and Federal Rule of Civil Procedure 65(a)(1).

This Court also finds, in the absence of adversarial presentation, that it has personal jurisdiction over Defendants because Defendants directly target their business activities

toward consumers in the United States, including Illinois. Specifically, BAIMEI has provided a basis to conclude that Defendants have targeted sales to Illinois residents by setting up and operating e-commerce stores that target United States consumers using one or more seller aliases, offer shipping to the United States, including Illinois, and have sold products using infringing and counterfeit versions of BAIMEI's federally registered trademark (the "BAIMEI Trademark") and displaying BAIMEI's federally registered copyright (the "BAIMEI" Image) to residents of Illinois. [In this case, BAIMEI has presented screenshot evidence that each Defendant e-commerce store is reaching out to do business with Illinois residents by operating one or more commercial, interactive internet stores through which Illinois residents can and do purchase products using counterfeit versions of the BAIMEI Trademark and display the BAIMEI Image. *See* Docket No. [10-1], which includes screenshot evidence confirming that each Defendant e-commerce store does stand ready, willing and able to ship its counterfeit goods to customers in Illinois bearing infringing and/or counterfeit versions of the BAIMEI Trademark and utilize the BAIMEI Image.]

This Court also finds that the injunctive relief previously granted in the TRO should remain in place through the pendency of this litigation and that issuing this Preliminary Injunction is warranted under Federal Rule of Civil Procedure 65. Evidence submitted in support of this Motion and in support of BAIMEI's previously granted Motion for Entry of a TRO establishes that BAIMEI has demonstrated a likelihood of success on the merits; that no remedy at law exists; and that BAIMEI will suffer irreparable harm if the injunction is not granted.

Specifically, BAIMEI has proved a *prima facie* case of trademark infringement because (1) the BAIMEI Trademark is a distinctive mark and is registered with the U.S.

Patent and Trademark Office on the Principal Register, (2) Defendants are not licensed or authorized to use any of the BAIMEI Trademark, and (3) Defendants' use of the BAIMEI Trademark is causing a likelihood of confusion as to the origin or sponsorship of Defendants' products with BAIMEI. BAIMEI has proved a *prima facie* case of copyright infringement because (1) the BAIMEI Image is registered with the United States Copyright Office and (2) Defendants are not licensed or authorized to use the Long Tail Cat Image. Furthermore, Defendants' continued and unauthorized use of the BAIMEI Trademark and BAIMEI Image irreparably harms BAIMEI through diminished goodwill and brand confidence, damage to BAIMEI's reputation, loss of exclusivity, and loss of future sales. Monetary damages fail to address such damage and, therefore, BAIMEI has an inadequate remedy at law. Moreover, the public interest is served by entry of this Preliminary Injunction to dispel the public confusion created by Defendants' actions. Accordingly, this Court orders that:

1. Defendants, their officers, agents, servants, employees, attorneys, and all persons acting for, with, by, through, under, or in active concert with them be preliminarily enjoined and restrained from:
  - a. using the BAIMEI Trademark or any reproductions, counterfeit copies, or colorable imitations in any manner in connection with the distribution, marketing, advertising, offering for sale, or sale of any product that is not a genuine BAIMEI product or not authorized by BAIMEI to be sold in connection with the BAIMEI Trademark;
  - b. using or displaying the BAIMEI Image or any reproduction or substantially similar copy in any manner in connection with the distribution, marketing, advertising, offering for sale, or sale of any product that is not authorized by BAIMEI;

- c. passing off, inducing, or enabling others to sell or pass off any product as a genuine BAIMEI product or any other product produced by BAIMEI, that is not BAIMEI's or not produced under the authorization, control, or supervision of BAIMEI and approved by BAIMEI for sale under the BAIMEI Trademarks;
  - d. committing any acts calculated to cause consumers to believe that Defendants' products are those sold under the authorization, control, or supervision of BAIMEI, or are sponsored by, approved by, or otherwise connected with BAIMEI; and
  - e. manufacturing, shipping, delivering, holding for sale, transferring or otherwise moving, storing, distributing, returning, or otherwise disposing of, in any manner, products or inventory not manufactured by or for BAIMEI, nor authorized by BAIMEI to be sold or offered for sale, and which bear BAIMEI's trademark, including the BAIMEI Trademark, or any reproductions, counterfeit copies, or colorable imitations.
2. Defendants shall not transfer or dispose of any money or other of Defendants' assets in any of Defendants' financial accounts.
  3. Upon BAIMEI's request, Defendants and any third party with actual notice of this Order who is providing services for any of Defendants, or in connection with any of Defendants' Online Marketplaces, including, without limitation, any online marketplace platforms such as AliExpress, Individual Sites, shein, Alibaba Group Holding Ltd. ("Alibaba"), Payoneer, Amazon.com, Inc., LianLian Global, LL Pay U.S., LLC, and Lianlian Yintong Electronic Payment Co. Ltd. ("LianLian"), Stripe, Pingpong, and Walmart (collectively, the "Third Party Providers"), shall, within

seven (7) calendar days after receipt of such notice, provide to BAIMEI expedited discovery, limited to copies of documents and records in such person's or entity's possession or control sufficient to determine:

- a. the identities and locations of Defendants, their officers, agents, servants, employees, attorneys, and any persons acting in active concert or participation with them, including all known contact information and all associated e-mail addresses;
- b. the nature of Defendants' operations and all associated sales, methods of payment for services, and financial information, including, without limitation, identifying information associated with the Online Marketplaces and Defendants' financial accounts, including Defendants' sales and listing history related to their respective Online Marketplaces; and
- c. any financial accounts owned or controlled by Defendants, including their officers, agents, servants, employees, attorneys, and any persons acting in active concert or participation with them, including such accounts residing with or under the control of any banks, savings and loan associations, payment processors or other financial institutions, including, without limitation, PayPal, Inc. ("PayPal"), Alipay, Payoneer, Stripe, Pingpong, LianLian Global, LL Pay U.S., LLC, and Lianlian Yintong Electronic Payment Co. Ltd. ("LianLian")Alibaba, Ant Financial Services Group ("Ant Financial"), Amazon Pay, or other merchant account providers, payment providers, third party processors, and credit card associations (e.g., MasterCard and VISA).

4. Upon BAIMEI's request, those with notice of this Order, including the Third Party Providers as defined in Paragraph 4, shall within seven (7) calendar days after receipt of such notice, disable and cease displaying any advertisements used by or associated with Defendants in connection with the sale of counterfeit and infringing goods using the BAIMEI Trademark and utilizing the BAIMEI Image.
5. Any Third Party Providers, including PayPal, LianLian Global, LL Pay U.S., LLC, and Lianlian Yintong Electronic Payment Co. Ltd. ("LianLian"), Stripe, Pingpong, Payoneer, Alipay, Alibaba Group, Ant Financial, and Amazon Pay, shall, within seven (7) calendar days of receipt of this Order:
  - a. locate all accounts and funds connected to Defendants' seller aliases, including, but not limited to, any financial accounts connected to the information listed in Schedule A hereto, the e-mail addresses identified in Exhibit [One] to the Declaration of JUN WU, and any e-mail addresses provided for Defendants by third parties; and
  - b. restrain and enjoin any such accounts or funds from transferring or disposing of any money or other of Defendants' assets until further order by this Court.
6. BAIMEI may provide notice of the proceedings in this case to Defendants, including service of process pursuant to Fed. R. Civ. P. 4(f)(3), and any future motions, by electronically publishing a link to the Pleadings, this Order, and other relevant documents on a website and by sending an e-mail with a link to said website to the e-mail addresses identified in Exhibit [One] to the Declaration of JUN WU and any e-mail addresses provided for Defendants by third parties. The combination of providing notice via electronic publication and e-mail, along with any notice that

Defendants receive from payment processors, shall constitute notice reasonably calculated under all circumstances to apprise Defendants of the pendency of the action and afford them the opportunity to present their objections.

7. Schedule A to the Pleadings [DOCKET NO(s). 4, 8], Exhibits [Three and Four] to the Declaration of JUN WU [DOCKET NO. 10], and the TRO [DOCKET NO. 18] are unsealed.
8. Any Defendants that are subject to this Order may appear and move to dissolve or modify the Order as permitted by and in compliance with the Federal Rules of Civil Procedure and the Northern District of Illinois Local Rules. Any third party impacted by this Order may move for appropriate relief.
9. The \$36,000 bond posted by BAIMEI shall remain with the Court until a final disposition of this case or until this Preliminary Injunction is terminated.
