**[proposed] TEMPORARY RESTRAINING ORDER**

THIS CAUSE being before the Court on Plaintiff Collectanea J. Limited Ltd.'s ("Plaintiff" or "Collectanea")'s Renewed *Ex Parte* Motion for a Temporary Restraining Order, Including a Temporary Injunction and a Temporary Asset Restraint (D.E. 22), Motion for Electronic Service (D.E. 21), Motion for Leave to Conduct Expedited Third-Party Discovery (D.E. 15) and Motion to Seal (D.E. 14) (the "Motions") against the Defendants and this Court having heard the evidence before it hereby GRANTS Plaintiff's Motions in their entirety.

This Court finds that it has personal jurisdiction over the Defendants since the Defendants directly target their business activities toward consumers in the United States, including Illinois. (D.E. 6 at ¶32). Specifically, Defendants are reaching out to do business with Illinois residents by operating one or more commercial, interactive internet stores through which Defendants display, advertise, market, and offer for sale and sell products using Plaintiff's U.S. Copyright Registration Nos. VA 2-348-112 and VA 2-348-115, (D.E. 11-2, 11-3) (hereinafter, the "Beadnova

Copyrighted Works”) and/or U.S. Trademark Registration No. 4,663,497. (D.E. 11-1) (hereinafter, the “Beadnova Mark”).

This Court also finds that issuing this Order without notice pursuant to Rule 65(b)(1) of the Federal Rules of Civil Procedure is appropriate because Plaintiff has presented specific facts in the Declaration of Yu Chung Ting, (D.E. 11), the Declaration of Larry Ford Banister, II (D.E. 18-1) and the accompanying evidence (D.E. 13) showing that immediate and irreparable injury, loss, or damage will result to the movant before the adverse party can be heard in opposition. Specifically, there is good cause to believe that in the absence of an *ex parte* Order, Defendants could and likely would modify registration data and content, change hosts, redirect traffic to other websites in their control, and move any assets from accounts in U.S.-based financial institutions to offshore accounts. As this Court and other courts have recognized, proceedings against those who deliberately engage in trademark counterfeiting and copyright infringement are often useless if notice is given to the adverse party.

Accordingly, this Court orders that:

1. The third party platforms, including but not limited to Alibaba, Amazon, Aliexpress, Bonanza, eBay, Walmart, Payoneer, Paypal, Stripe, Pingpong, and LianLian Global, LL Pay U.S., LLC, and Lianlian Yintong Electronic Payment Co. Ltd. (“LianLian”), (hereinafter, “Third Party Providers”) are hereby required to comply by assisting to identify all accounts involved in the Defendants' alleged infringement scheme and by providing Plaintiff with information necessary to permit it to comply with this Court's order authorizing alternate service of process. The discovery shall be limited to:

- (a) all information, financial accounts and/or sub-accounts, associated with the Internet based e-commerce stores operating under the Seller IDs identified on the Amended Schedule "A" to the Amended Complaint in this action;
- (b) all other accounts which transfer funds into the same financial institution account(s) or any of the other financial accounts subject to this action;
- (c) an accounting of all funds restrained and identify the financial account(s) and sub-account(s) which the relevant accounts are related to;
- (d) the account transactions related to all funds transmitted into the financial account(s) and sub-account(s) subject to this action;
- (e) the true identities including names, addresses, email addresses, and IP addresses, of each person who registered, are listed in, logged into, used, or who otherwise handled or is associated with the financial/payment processing accounts of all Defendants;
- (f) the full list of stores and associated financial/payment processing accounts opened, operated by, or at any time used by the Defendants;
- (g) sales data upon request.

The discovery request here seeks to obtain information necessary to identify the Defendants and their sales data and of the accounts used in the infringement in order to properly identify and serve Defendants with notice of this action and any scheduled preliminary injunction hearing.

2. Defendants, their affiliates, officers, agents, servants, employees, attorneys, confederates, and all persons acting for, with, by, through, under or in active concert with them are temporarily enjoined and restrained from:

- (a) reproducing, utilizing, distributing copies of, making colorable imitations of, or publicly displaying the Beadnova Trademark and the Beadnova Copyrighted Works in any manner without the express authorization of Plaintiff;
- (b) using the Beadnova Trademark and Beadnova Copyrighted Works in connection with the publicity, promotion, sale, or advertising of any goods sold by Defendants;
- (c) committing any acts calculated to cause consumers to believe that Defendants' products are those sold under the authorization, control or supervision of Plaintiff, or are sponsored by, approved by, or otherwise connected with Plaintiff;
- (d) further infringing on Plaintiff's Beadnova Copyrighted Works and/or Beadnova Mark and/or damaging Plaintiff's goodwill;
- (e) otherwise competing unfairly with Plaintiff in any manner; and/or
- (f) using the Beadnova Mark or colorable imitations thereof; and
- (g) from secreting, concealing, destroying, selling off, transferring, or otherwise disposing of any assets or other financial accounts subject to this Order.

3. Defendants and any persons in active concert or participation with them who have actual notice of this Order shall be temporarily restrained and enjoined from transferring or disposing of any money or other of Defendants' assets until further ordered by this Court.

4. Each of the Defendants, its officers, directors, employees, agents, subsidiaries, distributors, and all persons in active concert or participation with any of the Defendants having notice of this Order shall immediately discontinue the use of the Beadnova Copyrighted Works and/or the Beadnova Trademark, or colorable imitations thereof, on or in connection with all internet based e-commerce stores owned and operated, or controlled by them, including the internet based e-commerce stores operating under the Seller ID's.

5. Each of the Defendants shall not transfer ownership of the Seller IDs during the pendency of this action, or until further Order of the Court.

6. Upon receipt of notice of this Order by electronic delivery, the Defendants and Third Party Providers, including any third party financial institutions, payment processors, banks, escrow services, money transmitters, or marketplace platforms that are providing services for any of the Defendants, including but not limited to Amazon, Walmart, Payoneer Paypal, Stripe, Pingpong, and LianLian Global, LL Pay U.S., LLC, and Lianlian Yintong Electronic Payment Co. Ltd. (“LianLian”) and their related companies and affiliates shall within two (2) business days after receipt of notice of this Order, locate and restrain the transfer of all funds, including funds relating to ongoing account activity, held or received for the Defendants’ benefit or to be transferred into the Defendants’ respective financial accounts, restrain any other financial accounts tied thereto, and immediately divert those restrained funds to a holding account for the trust of the Court. Such restraining of the funds and the disclosure of the related financial institution account information (as provided below) shall be made without notice to the account owners or the financial institutions until after those accounts are restrained. No funds restrained by this Order shall be transferred or surrendered by any Third Party Provider for any purpose without the express authorization of this Court.

7. In addition to other methods authorized by law, Plaintiff may provide notice of these proceedings to third parties by delivery of this Order and other relevant documents to the Online Marketplace platforms and/or Third Party Service Providers by email service.

8. Pursuant to Federal Rule of Civil Procedure 4(f)(3), the Plaintiff may serve Defendants with the Complaint, Summons, any motions, court orders or other litigation documents by email to Defendants at the email addresses provided to by the Third Party Providers, attaching

copies of each to the service email, and electronic publication, which are methods of service reasonably calculated to provide notice under the circumstances of this case.

9. Plaintiff may demand discovery directly from Defendants, pursuant to Federal Rules of Civil Procedure 33, 34, and 36, prior to a Rule 26 conference and within ten days, receive Defendants' responses under oath.

10. This Order shall apply to the Seller IDs, associated ecommerce stores and websites, and any other seller identification names, e-commerce stores, domain names, websites, or financial accounts which are being used by Defendants for the purpose of infringing the Beadnova Copyrighted Works and/or the Beadnova Trademark at issue in this action and/or unfairly competing with Plaintiff.

11. Plaintiff shall deposit with the Court Ten Thousand Dollars (\$10,000.00), either cashier's check, cash or a check from a law firm trust account, as security, which amount was determined adequate for the payment of such damages as any person may be entitled to recover as a result of a wrongful restraint hereunder.

12. Any Defendants that are subject to this Order may appear and move to dissolve or modify the Order on two days' notice to Plaintiff or on shorter notice as set by this Court.

13. The Clerk of the Court is directed to issue a single original summons in the name of "Defendants Huizhou Huicheng District Jinshiyuan Stone Firm and the Individuals, Partnerships and Unincorporated Associations Identified on the Amended Schedule A to the Amended Complaint" that shall apply to all Defendants. The combination of providing notice via electronic publication and e-mail, along with any notice that Defendants receive from payment processors, shall constitute notice reasonably calculated under all circumstances to apprise

Defendants of the pendency of the action and afford them the opportunity to present their objections.

14. The Clerk shall maintain D.E. 7, D.E. 12 and D.E. 13 and this Order under seal until further order of the Court.

This Temporary Restraining Order without notice is entered on this \_\_\_\_ day of October, 2025 and shall remain in effect for fourteen (14) days.
