FINAL JUDGMENT

THIS CAUSE was tried before a jury on December 1, 2025. Defendants, Louis Capolino and Joseph Oren Tal f/k/a Oren Fachler a/k/a Mitchell Rosenberg, were served notice of the jury trial. The jury returned a verdict in favor of Plaintiff for the total sum of \$3,600,000.00 on December 1, 2025.

It is therefore **ORDERED AND ADJUDGED** as follows:

1. Final Judgment is hereby entered in favor of Plaintiff, Larry Ford Banister II, whose address is 305 Broadway, Floor 7, New York, New York 10007, and against Defendant, Louis Capolino, whose address is 11586 Fountainhead Drive, Apt #203, Tampa, Florida 33626. Plaintiff shall recover from Defendant, Louis Capolino, the amount of **\$1,800,000.00**, which shall bear interest at the prevailing statutory interest rate from the date of this Judgment, adjusted annually on January 1 of each year in accordance with Section 55.03, Florida Statutes, until it is paid, for which total sum let execution issue instanter.

2. Final Judgment is hereby entered in favor of Plaintiff, Larry Ford Banister II, whose address is 305 Broadway, Floor 7, New York, New York 10007, and against Defendant, Joseph Oren Tal f/k/a Oren Fachler a/k/a Mitchell Rosenberg, whose address is 21218 NE 31st Place, Aventura, Florida 33180. Plaintiff shall recover from Defendant, Joseph Oren Tal f/k/a Oren Fachler a/k/a Mitchell Rosenberg, the amount of **\$1,800,000.00**, which shall bear interest at the prevailing statutory interest rate from the date of this Judgment, adjusted annually on January 1 of each year in accordance with Section 55.03, Florida Statutes, until it is paid, for which total sum let execution issue instant.

3. Unless this Final Judgment is satisfied or post-judgment discovery is stayed, Defendant, Louis Capolino, and Defendant, Joseph Oren Tal f/k/a Oren Fachler a/k/a Mitchell Rosenberg, shall each complete under oath Florida Rule of Civil Procedure Form 1.977 (Fact Information Sheet), including all required attachments, and return it to The LaRue Firm, PLLC, 558 W. New England Ave., Suite 210, Winter Park, FL 32789, within 20 days from the date of this Final Judgment. The Fact Information Sheet which the Defendants are required to complete under oath and return to Plaintiff's counsel is attached to this Final Judgment.

4. As the party recovering judgment, Plaintiff is entitled to recover his costs in this action from Defendants, Louis Capolino and Joseph Oren Tal f/k/a Oren Fachler a/k/a Mitchell Rosenberg, pursuant to Section 57.041, Florida Statutes.


