## Subscription Plan A — Attorney Consultation Plan

### Rate Change Notice

---

Effective at the end of this month (June 2026), our standard hourly rate will increase from \$300.00 per hour to \$400.00 per hour.

Clients with an existing retainer agreement will retain their current hourly rate as stated in that agreement, unless and until a new retainer agreement is executed with our office.

### Overview

---

To help clients manage rising legal costs, Lally Law is pleased to offer Subscription Plan A, a monthly subscription plan providing access to attorney consultation time at a discounted, predictable rate.

Subscription Plan A is available to both new and existing clients of Lally Law Group.

### Plan Cost and Included Services

---

- **Monthly Cost:** Subscription Plan A provides \$200.00 of “Attorney Time Consultation” per month.
- **Included Services:** Attorney Time Consultation includes consultation by telephone or Zoom, as well as document review and review of correspondence.
- **Excluded Services:** Attorney Time Consultation does not include drafting of documents, court hearings, or trials, unless specifically agreed upon in advance.

### Additional Consultation Time

---

Once the \$200.00 of monthly Attorney Time Consultation has been used, clients on Subscription Plan A may purchase additional consultation time at a rate of \$100.00 per hour — a savings of \$300.00 per hour off the standard hourly rate for qualifying matters.

### Unused Time Policy

---

Attorney Time Consultation does not roll over from month to month. Unused time at the end of a billing period is forfeited (“use-it-or-lose-it”).

### Eligible Practice Areas

---

Subscription Plan A applies to the following areas of practice:

- General Civil Litigation
- Property Law
- Landlord-Tenant (Unlawful Detainer)

- Criminal Law
- Juvenile Law (including school matters)
- Gun Law (Example: Assistance in Obtaining a CCW [not guaranteed])

## Excluded Practice Areas

---

The following areas of practice are specifically excluded from Subscription Plan A, and shall remain billable at the standard hourly rate of \$400.00 per hour or an agreed flat fee or contingency fee unless otherwise agreed in writing:

- Family Law
- Employment and Labor Law
- Accepted Personal Injury Cases
- Workers' Compensation
- Wills and Estates

*This list is illustrative and not exhaustive. Lally Law Group reserves the right to identify additional excluded matters on a case-by-case basis.*

## Multiple Matters

---

The \$200.00 monthly subscription covers one matter per client. Clients with multiple, separate matters must purchase an additional Subscription Plan for each additional matter.

## Scheduling

---

- Attorney Time Consultation is available weekdays, 10:00 a.m. to 5:00 p.m. Pacific Time, excluding the noon hour.
- Previously scheduled matters and scheduled court hearings shall take precedence for scheduling purposes.
- Subscription Plan A guarantees access to an attorney during available working hours, subject to the scheduling priorities above.

## Billing and Payment

---

- Clients must provide a valid credit card (Visa, Mastercard, or American Express) on file for billing purposes.

- Recorded times are registered in 1/6 increments. The smallest time unit registered is a 1/6 increments.
- Billing periods are monthly.

## Cancellation Mid-Billing Period

If a client cancels Subscription Plan A during a billing period, the client shall remain enrolled in the plan, with access to its benefits, for the remainder of that billing period.

## Termination

Subscription Plan A may be terminated by either party at any time with thirty (30) days' written notice.
