Gay-rights activists protest Prop. 8 at Capitol

Opponents of Proposition 8 might have to go back to the ballot to reverse the ban on same-sex marriage, speakers told a crowd of about 5,000 at a loud and enthusiastic gay-rights rally in front of the state Capitol on Saturday.

Although the state Supreme Court has agreed to hear a challenge to Prop. 8 early next year, preparations already are being made to fight the battle for marriage rights all over again if the court doesn't overturn the constitutional amendment passed by voters in November, said Geoff Kors, executive director of Equality California.

"We can't just sit around until June and see what (the justices) do," he said. "We will take this back to the ballot if we have to and get our rights back."

More than 100,000 people already have pledged to carry petitions for a new ballot measure, which could come as early as the 2010 election, said Kors, whose group was one of the leaders of the "No on Prop. 8" effort.

"So we lost," said Robin Tyler, one of the plaintiffs in a case the state Supreme Court used in May to overturn Proposition 22, a statutory marriage ban approved in 2000. "It's only a battle and this is a war. And we'll win the war."

Any new campaign would be very different from the unsuccessful push to stop Prop. 8, the speakers agreed. There will have to be an improved effort to go out and make the case for marriage equality to the religious groups that provided much of the support for the measure.

"There's no road to success that doesn't go through **religion-based homophobia**," said the Rev. Lindi Ramsden of the Unitarian Universalist Legislative Ministry. "This is a community that's very good at talking to ourselves. Now we need to talk to others."

The results of the Nov. 4 election shocked many in the lesbian, gay, bisexual and transgender community, who never believed Californians would vote 52 percent to 48 percent to eliminate the right to same-sex marriage. Since the election, rallies and marches against Prop. 8 have brought hundreds of thousands of people out into the streets across the nation.

Even though the election is over, the protests send an important message to Californians, said Mike Bennett of Sacramento, who was at the rally with his partner and their two children.

"We got complacent, and a lot of us wish we'd done more of this before people went out and voted," he said. "But it just seems completely obvious that our household doesn't affect anyone else's household."

It is important to show California how many people care deeply about the same-sex marriage issue, Kors said.

"To go invisible after having our rights were taken away would have been giving up," he added.

Protesters filled much of the lawn beyond the Capitol steps, carrying homemade signs with messages like "What's so scary about our love?" and "Give tolerance a chance." Vendors walked through the crowd, selling gay-rights buttons and rainbow flags.

The crowd was much smaller than the 15,000 to 30,000 organizers originally had advertised or even the scaled-back 10,000 they hoped for this week. But while the rally was talked up in the days after the election, the actual organizing was done on the fly.

"There was a lot of buzz about this, but no real information," said Keegan Killian of California Outreach, one of the organizers. "Our first planning meeting was little more than a week ago."

The event featured some big-name speakers, such as civil rights attorney Gloria Allred, comedian **Margaret Cho** and state Sen. Darrell Steinberg, D-Sacramento, who will take over as leader of the state Senate next month.

While the crowd was peaceful and relaxed, there were plenty of hot words from the speakers, many of them aimed at the people and organizations who backed Prop. 8.

Tyler, a longtime activist for lesbian rights, argued that same-sex marriage opponents have no right to complain about any physical and verbal attacks they've encountered since election day.

"Get over it," she said. "It's easier to wash a paint stain off a church than to take off the stain they left on the California Constitution."

Cho, whose comedy routines are anything but G-rated, provided a song she wrote slamming Mormons for their support of the measure, ending with a chorus suggesting that voters not let the Mormons get away with what they did.

As has been the case at almost all the postelection rallies, supporters of Prop. 8 were invisible Saturday, declining to respond to the attacks or stage counterprotests.

"Getting involved in protests would undermine our point that the election is over and we won," said Andrew Pugno, an attorney for the Prop. 8 effort. "It seems pretty basic to me."

But for the opponents of Prop. 8, the election might be over but the battle continues.

"Anything worth fighting for oftentimes is a struggle," Steinberg said. "But the arc of history moves forward, it doesn't move backward. Prop. 8 is only a temporary setback."

Cisco cans Christian consultant

An American-based corporation that designs and sells consumer electronics and provides communication services has allegedly fired one of its leadership consultants for his political and religious views on same-sex "marriage." Dr. Frank Turek has gone public with his story.

In 2008, Turek was hired by San Jose, California-based Cisco Systems to design and conduct a leadership and team-building program. After completing a training session earlier this year, a manager in that session phoned in a complaint to Marilyn Nagel, senior director of inclusion and diversity for Cisco, after learning about Turek's book *Correct, Not Politically Correct: How Same-Sex Marriage Hurts Everyone*.

"The guy who saw the book never read it -- he just didn't like the fact that I was against same-sex marriage," Turek tells OneNewsNow. "And he told the in-charge director there about it and they fired me within hours, without ever even looking at the book or even ever asking me a question. They just fired me without ever talking to me."

Turek says he challenged Nagel about how he could be fired for embracing a conservative worldview which was never discussed in the workplace, but contends he was only given platitudes about the "inclusive" work environment of Cisco.

"She wouldn't recognize the fact that there is a systemic problem in the culture -- it's not inclusive and diverse," Turek argues. "Inclusion and diversity' only means if you agree with us, you'll be included. That's not inclusion -- and it's certainly not diversity."

Earlier in June, Turek contends a same-sex marriage forum led by a Cisco vice president on the campus of Cisco Systems only presented the "marriage equality" perspective of the issue. In a letter written to Cisco president John Chambers, Turek states: "One of the speakers at your one-sided 'forum' was a gay activist who helped Holland become the first nation to legalize same-sex marriage." That activist was Boris Dittrich, a former member of the Dutch Parliament and one of its first openly homosexual members.

"In my research," Turek continued in his letter, "I also noticed that the Honorable Evan Low was a panelist on that one-sided 'forum.' At age 26, Mr. Low was among the youngest mayors in the United States. As a gay man (your own website says) 'he brought unique perspectives to the office' of mayor."

Several letters seeking an explanation have been written to John Chambers, president of Cisco Systems, but Turek says Chambers has not replied.

Turek hosts the program [CrossExamined](#), which airs Saturdays on [American Family Radio](#).

Several years ago, Allstate Insurance employee Matt Barber [claimed to have been fired](#) for writing an article -- on his own time and with his own equipment -- critical of homosexual marriage. His lawsuit against Allstate was settled in early 2006. ([Read Barber's reaction](#))

Anarchists that invaded Mich. church lose to the rule of law

Federal court permanently prohibits members of Bash Back! from invading U.S. churches

7/12/2011

EAST LANSING, Mich. — An anarchist group and its members may no longer invade churches anywhere in the country unless they want to be held in contempt of court and fined \$10,000, according to orders issued by a federal judge Monday. The orders came in a [lawsuit filed by the Alliance Defense Fund](#) on behalf of a Michigan church after members of the group Bash Back! invaded one of the church's worship services in 2008.

Several individuals who participated in the invasion agreed to the [permanent injunction](#) in the case, *Mount Hope Church v. Bash Back!*, but the U.S. District Court for the Western District of Michigan had to issue a [separate default judgment](#) against Bash Back! and Bash Back! Lansing after the two groups failed to respond to the lawsuit or to communications from the court. Bash Back! openly advocates the use of riots and crime to further its views in favor of homosexual behavior.

"The use of violence, threats, and other criminal behavior to advance a political agenda should never be acceptable in America," said ADF Legal Counsel Dale Schowengerdt. "ADF filed suit on behalf of Mount Hope to stop Bash Back! from invading churches, disrupting worship, and terrifying adults and children who attend religious services. The court's orders accomplished that and send a message to any other groups contemplating such tactics that they will not succeed."

The Lansing chapter of the group targeted Mount Hope because of the church's well-known Christian views on marriage and homosexual behavior. Through [a page of the Bash Back! website](#), the group covertly recruited people for its plans to invade the church's most heavily-attended worship service, seeking some participants who would be willing to maintain "a more 'militant'-looking presence out side [sic] of the building."

"I can tell you that we are targeting a well-known anti-queer, anti-choice radical right wing establishment," the page said. "However, we cant [sic] give you really any detailed information due to the cop who's ridiculous job it is to do surveillance over this blog.... 'ONLY ONE DIRECTION! TRANS AND QUEER INSURRECTION!' - Bash Back! Lansing"

On Nov. 9, 2008, members of the group dressed in militant garb [staged a protest](#) outside the church to distract security personnel, blocking access to the building and parking lot at various times. Other members of the group dressed in plain clothes then deceptively entered the building. At a coordinated time, they sprang up shouting religious slurs, unfurling a sign, and throwing fliers around the sanctuary while two women began kissing near the podium. The group pulled fire alarms as they ran out of the building. After the incident, [the group bragged about its activities on its website](#).

Federal law imposes penalties upon anyone who "by force or threat of force or by physical obstruction, intentionally injures, intimidates or interferes with or attempts to injure, intimidate or interfere with any person lawfully exercising or seeking to exercise the First Amendment right of religious freedom at a place of religious worship."

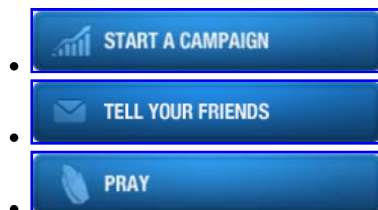

CONSENT ORDER GRANTING PERMANENT INJUNCTION

This case arose out of the Defendants’ protest at and disruption of Plaintiff Mount Hope’s church service on November 9, 2008. Mount Hope filed suit, alleging that the Defendants’ actions constituted acts of physical obstruction and intimidation in violation of 18 U.S.C. § 248, and common law trespass. The Plaintiff and the individually named defendants (collectively, “Individual Defendants”) have settled the Church’s claims and Defendants have consented to entry of a permanent injunction.

Therefore, for good cause shown and by the consent of the parties, defendants Anton Bollen; Wendie Renae Debnar; Spencer Dilday; Amy “Andy” Michelle Field; Nathan James Keller; Melissa Kim; Samuel D. Kreuger; Ryan Levitt; Cailin Elizabeth Major; Devin Scott Merget; Kelsey Myking; Allison “Ryan” Margaret Pennings; and Michele “Tyler” Nicole Troutman are:

1. permanently enjoined from entering any of Mount Hope Church and International Outreach Ministry's property without written consent from a member of Plaintiff's pastoral staff, and from harassing or intimidating any of Mount Hope's church members or staff;
2. permanently enjoined from disrupting a religious service anywhere in the United States by shouting, yelling, throwing objects, unfurling a banner or displaying any other sign not approved by the church, or by otherwise causing a disturbance. The Defendants shall retain their right to engage in lawful First Amendment speech in a public forum;
3. permanently enjoined from conducting a protest on the private property of any place of worship in the United States;
4. permanently enjoined from blocking, impeding, or making unreasonably difficult ingress or egress to entrances and/or exits of any place of worship in the United States;
5. permanently enjoined from blocking, impeding, or making unreasonably difficult ingress or egress onto property by vehicular or pedestrian traffic at any place of worship in the United States; and
6. permanently enjoined from destroying property at any place of worship in the United States.

It is further ordered that, by consent of the parties, Defendants Anton Bollen; Wendie Renae Debnar; Spencer Dilday; Amy "Andy" Michelle Field; Melissa Kim; Samuel D. Kreuger; Ryan Levitt; Cailin Elizabeth Major; Devin Scott Merget; Kelsey Myking; Allison "Ryan" Margaret Pennings; and Michele "Tyler" Nicole Troutman shall pay Mount Hope total damages of \$2,500 within 90 days of the Court's entry of this consent order. Defendant Nathan James Keller shall pay Mount Hope damages of \$250 within 90 days of the Court's entry of this consent order.

Violations of this order may be enforced by appropriate motion. If any defendant named in this order is found to have violated this Consent Order, he or she shall be subject to a fine of \$10,000 and reasonable attorneys fees and costs associated with enforcement of this order.

This action is dismissed with prejudice against the individual defendants named in this order.

Barker Town Clerk resigns over same-sex marriage

BROOME COUNTY, N.Y. -- New York has lost its first town clerk to the same sex marriage law.

Laura Fotusky is the Town Clerk in Barker, in Broome County, but she will leave her job on July 21st. Claiming there is a "higher law" which she must follow, Fotusky says she will step aside rather than issue marriage licenses to same-sex couples beginning July 24th.

Saying that the Bible clearly says marriage is between a man and a woman, the clerk said in her resignation letter, "we ought to obey God rather than men."

The website New Yorkers for Constitutional Freedoms posted Fotusky's entire letter on their [website](#).

In New York City, Governor Cuomo says Fotusky should step aside.

"The law is the law. When you enforce the laws of the state, you don't get to pick and choose which laws. You don't get to say, I like this law. I'll enforce this law. I won't enforce this law. You can't do that. So if you can't enforce the law, then you shouldn't be in that position," Cuomo said.

First Town Clerk Announces Resignation in Light of Gay "Marriage" Legislation



Much has been made of the fact that an amendment guaranteeing religious freedom was included in New York's recently-passed same-sex "marriage" law. Senators Mark Grisanti (R-Buffalo) and Stephen Saland (R-Poughkeepsie) touted this effort saying it was instrumental to securing their support for the legislation.

The problem for people of faith, however, is that the language is sorely lacking. The bill claims to protect pastors from having to perform same-sex ceremonies and churches from having to host gay weddings or receptions, but these protections were already present under existing constitutional protections. The "Marriage Equality Act" failed to include religious freedoms protections for individuals and non-religious affiliated organizations.

For licensed Christian counselors, not directly affiliated with a church, a day may come when the state may refuse licensure to those who practice reparative or ex-gay therapy. Wedding photographers and caterers will similarly find no protection. Refuse to photograph or serve a gay nuptial and people with strong convictions concerning the authentic definition of marriage will find themselves vulnerable to a lawsuit.

Soon town clerks and justices will also be required to issue gay "marriage" licenses. New York City Mayor Bloomberg announced that city clerks' offices will be open throughout the City on Sunday, July 24 – the first day that New York's new same-sex "marriage" law takes effect. The Big Apple won't be the only city making special accommodations for gay nuptials. Albany, Binghamton, Rochester, and many others have announced similar intentions. Not all are excited

Laura L. Fotusky, Town Clerk, Barker, may be the first New York State clerk to actually resign, rather than place her name on a same-sex "marriage" license. In a resignation letter presented to the Barker Town Board on July 11, Ms. Fotusky presented the following letter of resignation:

"To the Town of Barker Board, Supervisor Dilworth, Attorney Lewis and the Town Residents,"

"I have been in contact with Jason McGuire from New Yorkers for Constitutional Freedoms, our Town Attorney, Richard Lewis, and a Constitutional Lawyer regarding the Marriage Equality Act that was passed June 24, 2011. There was no protection provided in the legislation for Town Clerks who are unable to sign these marriage licenses due to personal religious convictions, even though our US Constitution supports freedom of religion."

"I believe that there is a higher law than the law of the land. It is the law of God in the Bible. In Acts 5:29, it states, 'We ought to obey God rather than men.'"

"The Bible clearly teaches that God created marriage between male and female as a divine gift that preserves families and cultures. Since I love and follow Him, I cannot put my signature on something that is against God. Deuteronomy 10:12 says, '...What does the Lord your God ask of you but to fear the Lord your God, to walk in all His ways, to love Him, to serve the Lord your God with all your heart and soul, and to observe the Lord's commands and decrees that I am giving you today for your own good.'"

"I would be compromising my moral conscience if I participated in the licensing procedure. Therefore, I will be resigning as of July 21. I wanted you to know my position as I understand the marriage law goes into effect on July 24."

"It has been a pleasure and privilege to serve the Town as Barker Town Clerk."

Rev. Jason J. McGuire, Executive Director, New Yorkers for Constitutional Freedoms, said, "It is unfortunate that when state senators were busy protecting liberal special interests and padding their campaign accounts, that they failed to protect good people of faith."

New York town clerk quits over gay marriage licenses

HUDSON, New York (Reuters) - A town clerk in western New York has resigned to avoid being forced to sign marriage licenses for gay and lesbian couples, citing religious objections to same-sex marriage.

Laura Fotusky, the town clerk in Barker, New York, said in her resignation letter that she will step down on July 21, three days before New York becomes the sixth and largest state to allow gay nuptials.

Governor Andrew Cuomo signed the same sex marriage law last month after the bill narrowly passed the Republican-led state Senate. Its approval in New York is seen as a catalyst for gay marriage elsewhere as well as helping push the issue to the forefront nationally ahead of the 2012 elections.

Much of the debate in New York focused on the scope of protections for those opposed to same-sex marriage. The new law exempts religious groups from performing same-sex marriages but does not extend those protections to individuals, including government employees.

Fotusky was not immediately available for comment, but in her letter, dated July 11, she said she believes the Bible takes precedence over man-made laws.

"The Bible clearly teaches that God created marriage between male and female as a divine gift that preserves families and cultures. Since I love and follow Him, I cannot put my signature on something that is against God," she wrote.

"I would be compromising my moral conscience if I participated in the licensing procedure," she wrote.

According to New Yorkers for Constitutional Freedoms, a conservative Christian nonprofit group that circulated Fotusky's letter to the media, she is the first clerk in the state to resign over objections to same-sex nuptials.

But she is not the first to raise concerns. Two weeks ago, the town clerk in the Syracuse suburb of Volney cited her own religious objections and requested that outside help be brought in to sign same-sex marriage licenses.

Cuomo, who had made the legalization of same-sex marriage a top priority this year, told reporters on Tuesday that he agreed with Fotusky's decision to resign because government workers have a responsibility to enforce the law.

"When you enforce the laws of the state, you don't get to pick and choose the laws," Cuomo said.

Conscientious objection among government employees has been an issue in some other states that allow gay marriage.

In Massachusetts, more than a dozen justices of the peace threatened to resign in 2004 after a state court ruled that barring same-sex marriages was unconstitutional, and at least one resigned. In 2000, the town clerk in Tunbridge, Vermont resigned even though state law would have allowed her to appoint someone else to sign marriage licenses.

Robin Fretwell Wilson, a professor at Washington and Lee Law School in Virginia, has lobbied lawmakers in New York and other states to exempt individuals, including government employees, from providing services to same-sex couples. In a 2010 paper, she argued that the religious beliefs of marriage officers should be accommodated as long as they pose no hardship to same-sex couples.

"Forcing a public employee with a religious objection to facilitate a same-sex marriage would be intolerant in the extreme when little is to be gained by such rigid demands," wrote Wilson, who was not available for comment on Tuesday.

On Election Day November 4, 2008, the most highly contested ballot measure in California was Proposition 8. Entitled "Eliminates the Right of Same-Sex Couples to Marry", the purpose of Proposition 8 was to amend the state constitution to remove the constitutional right of gays and lesbians to marry.

Proponents of Prop 8 waged a successful campaign to strip lesbian and gay citizens of their civil rights aided in large part to the nearly \$40 million they raised. Many of these donations came from businesses throughout California and across the country.

These businesses have the right to support whatever ballot measures they want, but fair-minded citizens of all sexual orientations also have the right to take their money elsewhere and not patronize businesses that support bigotry. This site is not a witch-hunt but is a tool intended to help people make informed decisions when they shop for products and services. This site hopes to overcome some of the limitations of existing Prop 8 donor databases on the web and in time hopes to become a useful repository of all companies in the U.S. with anti-gay policies.

Using publicly available information from the California Secretary of State's website, DontBuyFromBigots.com strives to be the most comprehensive business-specific listing of donors to Prop 8. 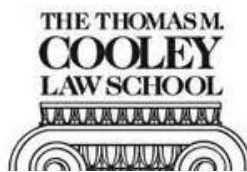

"When you enforce the laws of the state, you don't get to pick and choose the laws," Cuomo said.
