I, Larry Stickney, make the following declaration pursuant to 28 U.S.C. § 1746:

1. I am a resident of the state of Washington over 18 years of age, and my statements herein are based on personal knowledge.

2. As stated in the Verified First Amended Complaint, I am the Campaign Manager for Protect Marriage Washington (“PMW”).

3. The phone number used by the campaign was my personal cell phone number.

Throughout the campaign, especially after the petition signatures were gathered, I received countless phone calls from individuals screaming obscenity-laced verbal assaults, most often of a sexual nature. I received these calls at all hours of the day and night. The calls were so voluminous that the messages would fill up my voice mail box and, as I deleted the older

1 messages, newer messages would fill the box up again within a short time frame.

2 4. Additionally, throughout the campaign, I received numerous calls at my home phone
3 number. This phone number was not publically connected with the campaign. On occasions too
4 numerous to recall, I received calls at my home, sometimes in the middle of the night, from
5 individuals screaming obscenity-laced verbal assaults, most often of a sexual nature.

6 5. Many of these individuals left messages on our family's voice mail machine. Often
7 times, the individuals would specify that the messages were intended for "Larry Stickney and
8 his family," and would follow with a string of vulgar and defamatory statements.

9 6. True and correct audio files of four such voice mails are attached herein.


