

1 Pursuant to the Plaintiffs’ Motion for Immediate Payment of Minimum Share  
2 (“Motion”), and for good cause showing, the Court grants the Motion as follows:

3 The United States shall, within 30 days, pay the Relators via wire  
4 instructions provided by Relators’ counsel:

- 5 1. The minimum 15% share of the federal share of the intervened claims settlement  
6 in the amount of \$948,580.36; and
- 7 2. The minimum 25% share of the federal share of the non-intervened claims  
8 settlement in the amount of \$531,595.97.
