Program Parameters

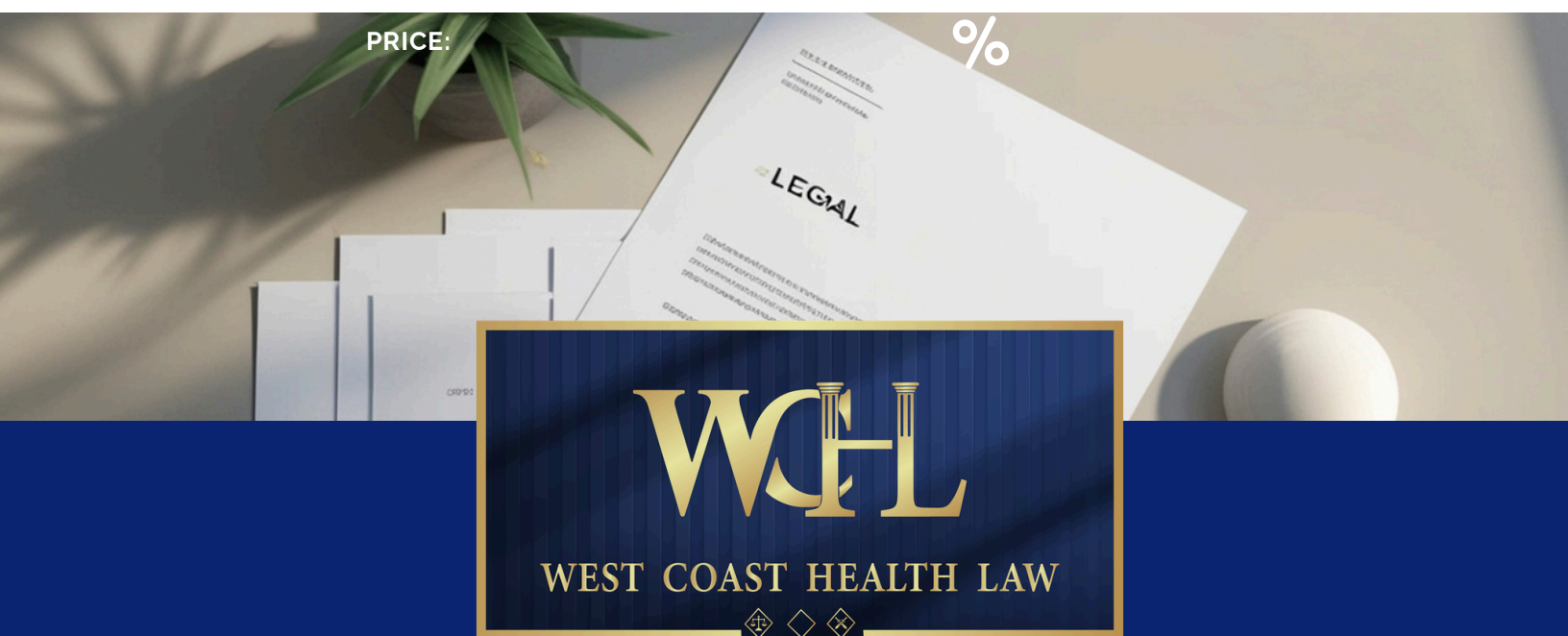
This program is structured for strategic, non-urgent legal work.

It is not designed for:

- Same-day legal demands
- Court deadlines
- Litigation emergencies
(our office does not currently handle litigation matters)
- Regulatory response deadlines

Urgent or time-sensitive matters may be handled separately as paid consultations, subject to availability and scope of representation.



Understanding Project Classifications

Projects are categorized internally by scope, complexity, and anticipated time investment. Classification is determined solely by West Coast Health Law Group.

Some matters cannot be fully evaluated until review begins. If a matter exceeds the anticipated scope, additional credits or a separate engagement may be required.

There are no guaranteed turnaround times due to the value-based structure of this program. Response tiers refer to acknowledgment order and internal scheduling priority.

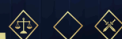
Examples of Minor Projects

- Single entity filing, amendment, or fictitious business name filing
- License address update or administrative filing
- Review of a short contract with summary explanation (no drafting)
- Brief employment law guidance (PTO, overtime classification, policy clarification)
- Draft or revise a discrete employment policy
- 20-minute attorney consultation
- Communication coordination with vendor or consultant (non-adversarial)
- Warm referral to outside counsel or specialist, where appropriate

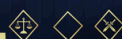
Examples of Comprehensive Legal Matters
